ORDER

Whereas, it is a known fact that most of the passengers coming from outside the state travels through railways and hence it has become very essential that strict vigil and screening of the passengers to be carried out in every railway station.

Whereas it has been observed that, the screening of the passengers coming from outside is not satisfactory in the railway stations under Kamrup Metropolitan District. On 15/03/2020 a suspected case of virus affected passenger came to the notice of District Administration and immediately the passenger was quarantined in the Guwahati railway Station. During the process, it was also observed that the required screening of passengers was not found carried out by the Railway Authority

Whereas, if such cases goes unnoticed, this may cause spreading of the virus and may create havoc among the public in general. Therefore, screening of each and every passenger at source i.e. in the Railway stations itself will reduce the spread of this pandemic.

I therefore, **Sri Biswajit Pegu, IAS, Deputy Commissioner & Chairman**, District Disaster Management Authority as per the power conferred upon me under Section-30 sub Section 2 (iii),(iv),(v), (xi) and 34 (c) of Disaster Management Act 2005, hereby direct the Principal Chief Medical Director, North Eastern Frontier Railways to immediately take appropriate necessary measures with sufficient manpower and equipment required for screening and diagnosis of the passengers coming from outside the state in all the railway stations under Kamrup Metropolitan District with immediate effect.

This order comes into force with immediate effect.
