

Minutes of the State Level Empowered Committee Meeting on CORONAVIRUS (COVID-19) held on 5th May, 2020 at Chief Secretary Conference Hall, Dispur

The list of officers present in the meeting is given at Annexure "A"

The meeting was chaired by Kumar Sanjay Krishna, Chief Secretary to the Govt. of Assam.

1. All industries and their supply chain are allowed to operate in the state without the need for any specific order. All personnel working therein are allowed to commute to work at all times.
2. Tea industries and workers engaged therein are allowed to operate at all times.
3. Warehouses are allowed to operate at all times and personnel required for their operation are allowed to move at all times.
4. All activities related to PDS operations, FCI warehouses, Railways, LPG and Petroleum delivery services and workers and staff engaged therein are allowed to operate at all times.
5. E-commerce delivery is allowed between 6 am and 6 pm only, however, backend activities and personnel engaged therein are allowed at all times.
6. All automobile dealerships and outlets are allowed to operate between 6 am and 5 pm.
7. Supply chain related to essential food items like milk, fish and other perishables including workers engaged therein are allowed to operate at all times.
8. All essential services including conservancy services by municipal bodies and other government agencies are allowed at all times.
9. Private offices located in the same building as that of a mall are allowed to operate but shops in the same building will not be allowed to open.
10. Shops in market complex are allowed to operate with two shops closed between two open shops. However, grocery shops, pharmacies and medical establishments situated therein are allowed to open on all days during the permitted hours.
11. All shops in rural areas, except in malls, are permitted to remain open, without any distinction of essential and non-essential.
12. All types of goods carrying vehicles are allowed to ply at all times.
13. All construction activities including highway construction, flood control works are allowed at all times.
14. Bank employees are allowed to move beyond 6 pm depending on necessity.
15. Large stand-alone shops are allowed to operate with limited number of entrants.
16. Media persons and persons engaged in printing newspaper and persons engaged in newspaper distribution are allowed to operate beyond the restricted time as per necessity.


All the above are allowed except in containment Zones and after following social distancing protocols. The head of the organization will be held responsible for violation of any COVID19 protocol.

17. Regarding movement of stranded people from other States of North East through Assam, ADGP (L & O) informed that
 - I. Till 4th May, 2020 (Evening) around 3900 migrants belonging to Assam have reached the State on their own.

- II. about 6000 people from Assam are willing to return from Meghalaya. However, Govt. of Assam needs to make necessary arrangement and suitable modalities need to be worked out for bringing them back.
- III. Govt. of Rajasthan requested to take back their stranded people from Assam by train, if approved by Govt. of Assam.

It was decided that regarding 15 (ii) above, the matter would be referred to Health & Family Welfare Department for eliciting their views by tomorrow. As regards 15 (III), there should not be any difficulty in acceding to the request of Govt. of Rajasthan.

The meeting ended with vote of thanks from the Chair.
