1. The envelope containing quotation should be super scribed "**Quotation for supply of Mobile Phones for ASDMA**". The bid must be submitted in two sealed envelopes
  - a. One for Technical Bids and
  - b. Second for Financial bids
2. Technical bid should contain the following
  - a. Rs. 100/- court fee stamp to be affixed along with the quotation
  - b. Copy of Registration Certificate/ trade licence
  - c. PAN card issued by Income Tax Department to be submitted.
  - d. Up-to-date GST registration in Assam must be submitted.
  - e. A copy of self certification that the bidder has not been under blacklisting by any State/Central Govt. organisation or Public Sector undertaking in prescribed format (Annexure-I).
  - f. Product brochure of the Mobile phone published by the OEM mentioning 1-(one) year of warranty on the model of the mobile phone as proposed in the bid document.
  - g. Particulars of the mobile phone proposed in the bid document in prescribed format (Annexure -II)
3. Financial bids of those Tenderers will be opened which qualifies the technical Bids
4. For the Financial Bid the following points must be followed
  - a. The Rates quoted must be inclusive of VAT Charges and other applicable taxes
  - b. The rates are to be quoted in figures as well as in words.
5. The rates accepted by ASDMA will remain valid for one year from the date of signing of the agreement.
6. The selection in the Financial Bid will be as per lowest quoted rate unless otherwise decided by the Authority
